

The Surgery Center, LLC Improves Adult and Pediatric Gastroenterology Procedure Notes by Replacing AmkaiCharts Templates with Provation® Apex

The Surgery Center, LLC is a multispecialty ambulatory surgery center (ASC) providing same-day outpatient surgery for Franklin, Wisconsin and the greater Milwaukee area. Accredited for meeting, and often exceeding, the highest standards of patient care, The Surgery Center is jointly owned and operated by independent physicians and Aurora Health Care.

Together, The Surgery Center's physicians perform an estimated 1,500 adult and pediatric gastroenterology (GI) procedures per year at the facility. For years, physicians were documenting GI operative notes using AmkaiCharts templates. According to doctors, these templates were inefficient and required a lot of free text typing, which also led to a lack of standardization across physicians. Needless to say, there was room for improvement.

"We know the importance of physicians' satisfaction with the clinical software and how it impacts doctor recruitment, retention and productivity. And because The Surgery Center is owned, operated and boarded by physicians, their satisfaction is even more critical," said Executive Director, Fawn Esser Lipp. "Our physicians and leadership team recognized it was time to upgrade to a new EHR, and so that's what we did."



All EHRs Have Limitations

After researching and weighing features, benefits and incentives, The Surgery Center replaced its Amkai EHR with SIS Charts™ – a cloud-based EHR owned by Surgical Information System (SIS). SIS is the same company that acquired AmkaiSolutions in 2014. Ideally, they wanted one solution for clinical workflows, and although SIS Charts has the benefits of the cloud, they quickly learned it also has limitations.

"Even before completing our purchase, we determined SIS Charts, like many EHRs, did not offer a good solution for documenting procedures – especially endoscopy procedures," said Esser Lipp. "We would not be solving our procedure note inefficiencies with the EHR alone, so we still needed a procedure documentation solution."

"Surprisingly, during our EHR vetting process, more than one software vendor recommended adding Provation to the EHR for procedure documentation, so we knew it was something to consider," she said.

In addition to vendor recommendations, The Surgery Center's resident physicians also influenced their decision to add Provation.

"Dr. Alan Mayer, our resident pediatric gastroenterologist, also performs procedures at Children's Hospital of Wisconsin, which uses Provation® MD for procedure documentation," explains Esser Lipp. "He loves the efficiency and accuracy Provation offers and he urged us to consider adding the software, regardless of which EHR we chose."
