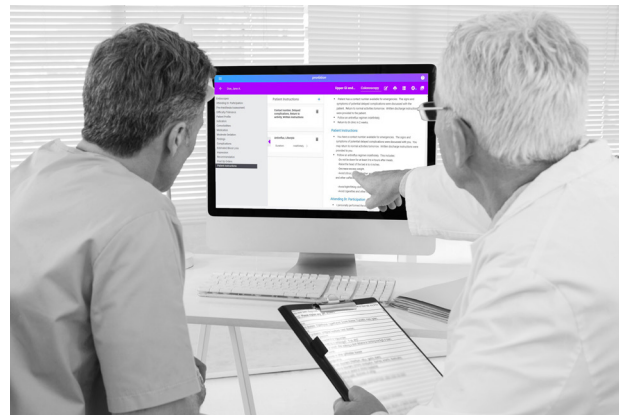
THE CHALLENGE

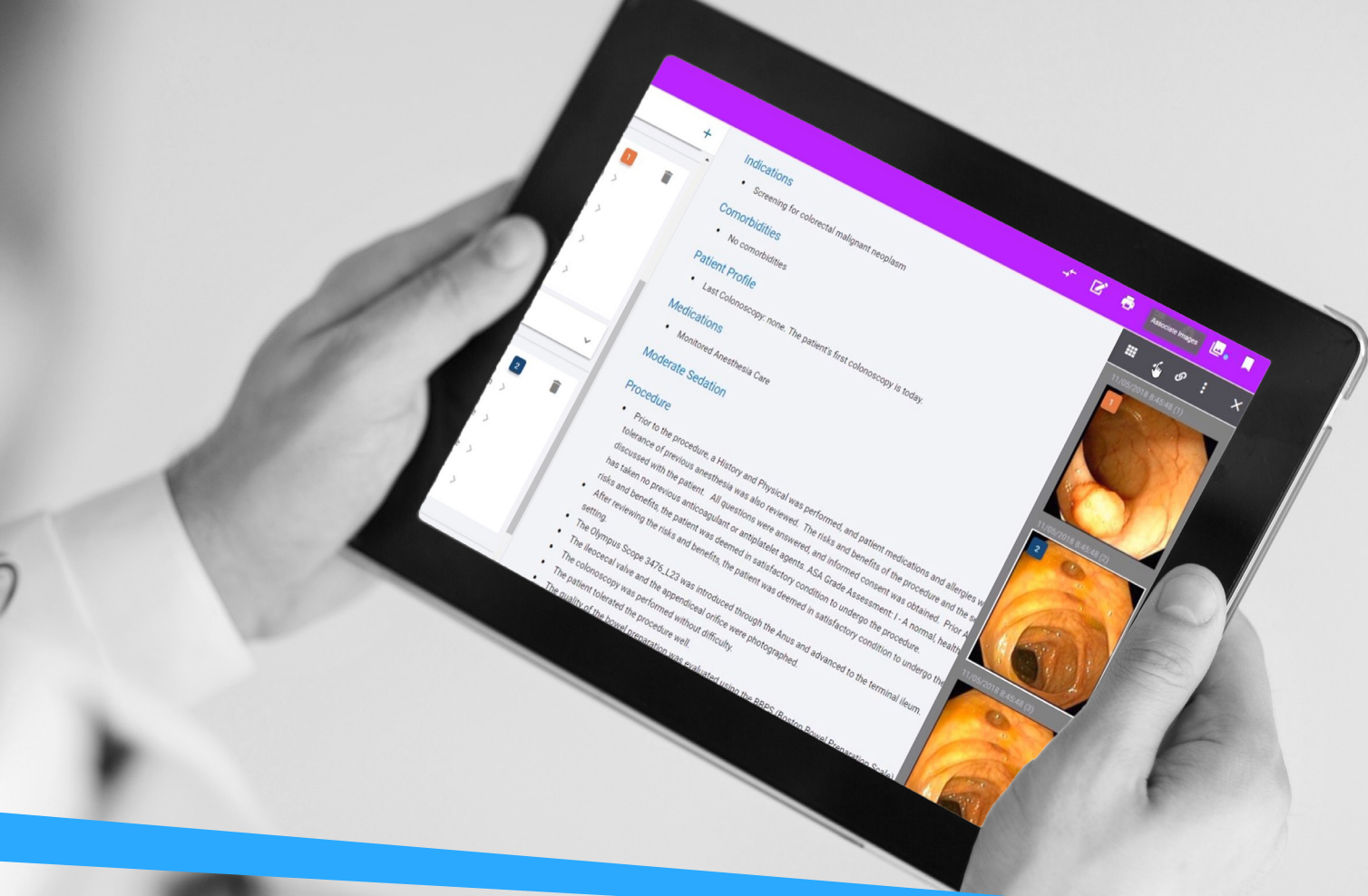
With a gastroenterology (GI) procedure volume of more than 7,000 procedures between their hospital and endoscopy center, a healthcare organization was looking for a way to standardize procedure notes and achieve maximum physician satisfaction.

They had been documenting with a well-known electronic health record (EHR) system, but soon discovered that EHRs can be inefficient and inaccurate when it comes to capturing images, diagnostic codes, and quality reporting.
